



ADVERT FOR A CONSULTANT TO CONDUCT A TRAINING OF TRAINERS FOR A COMMUNITY MODEL

African Centre for Treatment and Rehabilitation of Torture Victims (ACTV) is a Non-Governmental Organization dedicated to the promotion and protection of Human Rights with specific emphasis on advocacy against torture and provision of holistic rehabilitation services to survivors. These services are provided through ACTV's multidisciplinary team of Lawyers, Clinical Psychologists, Doctors, Nurses, Physiotherapists and Social Workers African Centre for Treatment and Rehabilitation of Torture Victims (ACTV) currently has two Centres, the head office in Kamwokya, Kampala-Central Uganda and a branch in Laylbi, Gulu-Northern Uganda. The African Centre for Treatment and Rehabilitation of Torture victims (ACTV) in partnership with DIGNITY, an independent Danish Human Rights organization, is implementing a pilot project in Uganda based on a community approach. The project is targeted towards increasing the reach of rehabilitation services to survivors of torture and organized violence in local communities through a community model. The community approach will empower a selected group of members within the local communities that will form a community support network responsible for providing basic psychological, social, treatment and referral services. The community support networks will entail community counsellors, peer support workers, community facilitators, rapid response networks and health workers. The project is implemented in Western Uganda, Kasese District in the Sub Counties of Hima and Bwesumbu for a period of eight (8) months.

The main objective of the project is; "TostrengthenACTV's organizational capacity to increase outreach to survivors of torture and organized violence through a community approach."

Purpose of the assignment

To build the capacity of ACTV staff to facilitate community support networks in the delivery of basic rehabilitation services through a community model.

- Extensive experience working in local community support structures and familiarity with the region of the project implementation and its cultures.
- Specific knowledge in the field of Human Rights and provision of rehabilitation services to Torture survivors.
- A university degree in the area of community development and international development.
